### Information about the service

#### The Service:

SIP Trunking is a voice telephony service that is supplied over your internet service. The internet service may be supplied by HM Telecom or by another service provider.

#### Bundling

In order to access the Service, you may need a dedicated or shared fixed line broadband Internet connection, such as ADSL 2+, NBN, SHDSL or Fibre service.

#### Mandatory components

You will need a broadband modem for the service to work. We recommend that the service be accessed with hardware supplied or approved by us. Please contact us for further information.

#### Minimum Term

The service is available with minimum term, 12, 24 or 36 month terms.

### Important conditions

If you have current numbers with another provider for your phone service and you would like to keep them, then they will need to be ported. Additional fees apply. HM Telecom plans do not support 19/1900 numbers calls, fax, dial up modem or other analogue data calls (e.g. EFTPOS, HICAPS), back to base alarms and other monitoring systems using phone lines, and similar features.

SIP Trunking Value Plan is not available for telemarketing, call centre function and similar uses. Fair use policy applies.

We will bill you in advance for the minimum monthly charge and features, and in arrears for calls.
